I remember last seeing No.6062 Pte Cobden R. of 22nd Btn A.I.F. at about 7.30 a.m. on 3.8.17 in a kind of trench which consisted of a series of shell holes about 5 yds in front of the German front line and just about 50 or 100 yds to right of Bullecourt I was wounded at the time and resting in a crouching position about 10 yds away when I saw about 20 members of the 22nd Btn taken prisoners including Pte Cobden. At the time he was taken prisoner he appeared to be quite well and unhurt. I no not know anything concerning his subsequent movements, welfare, and whereabouts.


