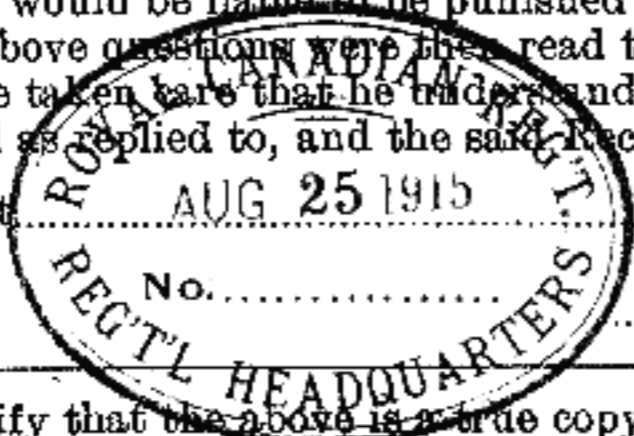
OATH TO BE TAKEN BY MAN ON ATTESTATION.
